SINGAPORE INTER SCHOOL SHOW CHOIR CHALLENGE 2012 (SSSC 2012) RULES & REGULATIONS

All participants of SSSC 2012 are required to adhere to this set of rules and regulations stipulated by the organisers to be eligible for participation in this competition

The organisers reserve the right to change, amend and/or withdraw any of the rules and regulations stipulated without prior notice.

1. Eligibility

This competition is open to all students of all secondary schools, international schools, vocational institutes/ITEs, junior colleges, centralised institutes, polytechnics, tertiary institutions, and universities under the age of 25. (as of December 31st, 2012)

2. Categories

- Category A - Youths studying in secondary schools/international schools between the ages of 12 - 17.
- Category B - Youths studying in vocational, tertiary, centralised institutes / ITEs / junior colleges / polytechnics / universities aged 25 and below.

3. Performance

All participating teams will perform two contrasting pieces, in any language.

Songs performed should not include any inappropriate obscene language/profanities. Please contact the organisers if in doubt. The organisers reserve the right to decline the school the chance to compete should the song be deemed inappropriate.

To avoid infringement of copyright laws, only original scores should be used during the performance. For enquiries on copyright, please contact the Composer and Authors Society of Singapore (COMPASS) at 6323 6630

Instruments and accompanying instrumentalists are allowed. The schools involved should provide instruments and required technical equipment.

Backing tracks may also be used. Schools are to ensure that the minus one does not have any pre-recorded vocal parts in it. The organisers have the right to disqualify any schools that breach this rule.

4. Duration

The total performance duration of both pieces should be between six to eight minutes.

10% of the final marks awarded will be deducted for any performance that exceeds eight minutes.

5. Attire

Participating schools must ensure that the participants do not wear revealing costumes during any stage of the competition.

6. Participants

Each school can send more than one team to participate in SISSC 2012 but the members in each team must be unique.

The registration fee per school is \$5/participant. Payment details will be confirmed upon registration.

Each team must have no less than 12 members and no more than 45 members. All participants must be current students of the school.

10% of the final mark will be deducted for choirs that field less than 12 members or more than 45 members.

A preliminary semi-final judging round will be arranged during the month of July. Representatives from John & Deniece Glee Studios will arrange to view, film and judge the school's show choir team live to be submitted to the judges for selection.

A maximum of 7 teams per category will be shortlisted for the finals.

7. Judging Criteria

Teams will be judged by a panel of judges appointed by the organisers. The decision of the panel is final and no correspondences or enquiries will be entertained.

The judging criteria are as follows:

7. Publicity

Each team must provide a brief description of their team, and also include a soft copy of a 4R photograph featuring all the team members to the organisers upon submitting the registration form.

The organisers reserve the right to publicise, and/or broadcast the participants' names, videos, pictures at any time they deem fit.

8. Parental Consent & Indemnity

All participants below the age of 21 are to obtain parental consent to join the competition. Teachers-in-charge/Leaders of each school team have to ensure that parents of the youths are informed.

The organisers will take absolute safety precautions to ensure that the competitions is held in a safe and conducive manner. They will however not be responsible for any injuries sustained during the course of this competition.

9. Prizes

The prizes for the winners of each category are as follows:

1st Prize: \$1,500 worth of Show Choir Training + Trophy + Cash Prize

2nd Prize: \$1,000 worth of Show Choir Training + Trophy + Cash Prize

3rd Prize: \$500 worth of Show Choir Training + Trophy + Cash Prize


